**Owner Contract**  
Terms and Conditions of Service

1. I understand that my pet(s) must be in good general health, parasite free, and current on vaccinations (For dogs: Rabies, DAPP, and bordetella; For cats: Rabies, FVRCP, yearly FeLV/FIV testing) to be admitted into this facility. I agree to provide proof of all required vaccinations upon first visit as well as when these vaccinations are updated annually.
2. I understand the PetMedSpa and Rehabilitation Center has the right to refuse admittance to any animal(s) not meeting general health and temperament requirements. PetMedSpa and Rehabilitation Center is relying on my assurance that my pet(s) are not a treat to any other person or animal and have not shown any potential for aggressive or dangerous behavior in the past.
3. I agree to pay a two-night deposit to hold my lodging reservation. I also understand that my deposit is non-refundable in the instance of reservations not terminated at least 3 days prior to check-in date.
4. I understand that for the safety and security of my pet(s), PetMedSpa and Rehabilitation Center has the right to refuse the release of an animal to anyone other than the owner if they are not informed, in writing, in advance of the arrangement.
5. I agree to drop-off and pick-up my pet(s) during posted times only for the convenience of PetMedSpa and Rehabilitation Center staff. Further, I understand that failure to do so may result in additional lodging fees. Exceptions to these times can be allowed if arrangements are made. Also, if I neglect to pick-up my pet(s) within 5 days of the expected date of departure, PetMedSpa and Rehabilitation Center will consider the animal(s) abandoned and has the right to relinquish the pet(s) the Almost Home Humane Society, and will no longer hold responsibility for the pet(s).
6. Due to the inconvenience caused by pets that are not picked up on the date indicated by their reservation, a late fee of \$5 for the first 3 days and \$10 for each additional day will be implemented.
7. Due to time consuming procedures when working with handle with care pets, there will be an additional \$5/day for any aggressive or temperamental pets. There will also be an extra charge of \$3.50/day for any pets that require extra cleaning, such as baths, or pets being moved into a new room daily to have theirs scrubbed down and disinfected due to frequent accidents.
8. I understand that I am responsible for any damage caused by my pet(s) while he/she is participating in activities or lodging at PetMedSpa and Rehabilitation Center, including bedding, if requested.

9. You are welcome to bring bedding and toys from home for your pet(s) to enjoy during his/her stay with us, but we cannot be held responsible for these items if they are lost or misplaced. We also do not have the equipment required to wash any blankets, comforters, pillows, or beds at our facility. If your pet has accidents on said items, they will be sent home in a bag for the owner to wash.
10. I agree that PetMedSpa and Rehabilitation Center will not be liable for any problems that develop provided reasonable care and precautions are taken. Any health or behavior issues will be treated as indicated by the Boarding Agreement; treatment provided is at the discretion of the PetMedSpa and Rehabilitation Center staff.
11. I understand that payment is due at the time of services rendered and I agree to pay all lodging charges in full as well as those incurred due to any necessary medical treatment, flea or tick prevention, or other fees as approved in the Boarding Agreement.
